- d) Mark (road superintendent) gave Pipelines cost sheet. Mark said he would like to replace a pipe on Wright St. Mark requested a 15 inch pipe 80 ft. long for this area. Ken made a motion for MC Professional Lawn services to mow cemetery and Benetka Rd for the 2016 season, Troy 2nd all in favor Resolution #28. Alan to contact Maurer's Mowing to let them know we are going with Mc Professional Lawn Services for the cemetery season 2016.
