#### II. <u>DISCUSSION</u>

Alan also said that he and Claude would be visiting the Ashtabula City Dispatch center on Wednesday. Alan also said he spoke with Randy Woodard (Fire Chief Pierpont) regarding dispatch services they were with the Sheriff Dept for dispatch and he said there were errors with the Sheriff dispatch so they went to Saybrook Twp. and have not had any issues. Alan said there is a county meeting at A-Tech. Alan also said the fire Dept has CPR training this Tuesday at 7pm.; also the new truck is in and getting a light package installed. Alan also said that Claude complemented the new firefighter he said he has been an asset for daytime calls.


Alan made a motion to accept the rates as determined by the budget committee for 2020, Ken 2<sup>nd</sup> all in favor resolution #53.
