Claude asked the trustees to approve the awards cost for the banquet of \$2382. Troy made a motion to cover \$2382 for awards for the banquet Alan 2nd all in favor Resolution #4. Claude also discussed the loss of Ray Howell. Claude said he thanked surrounding townships for covering our township for his funeral. Glen Thomas's son made a flag for the Fire dept. honoring Ray. Claude discussed the new truck bed issue and stated that it is getting fixed. Claude said there is an upcoming meeting with Plymouth Twp. regarding future dispatching. - e) Mark Degan (road dept.) thanked everyone for the flowers and dinner for Ray Howell. Mark stated the bid packet for Dewey Rd. is looking at February to be completed by the county. Mark briefly discussed getting a pole at Plymouth Ridge Rd and Dibble Rd. for a safety mirror. Dawn to call The Illuminating Co to inquire about cost. Mark stated he has been maintaining roads. The ice grit is also in. Marks also said John Griggs can use his excavator at the cemetery when needed. He briefly discussed the zoning issue on Rt.193.
- f) Alan Kohta (trustee) stated he drove roads potholes. He told Mark about a few branches in the cemetery. He also noticed a headstone that was broke. Alan thanked Ken for the food for Ray Howell. 
KEN MADE A MOTION TO CERTIFY THE CARRYOVER
