# **Meeting Minutes**

09/08/2015

CHAIRMAN Ken Kister called to order the regular meeting of the SHEFFIELD TWP. TRUSTEES at 7PM on 09/08/2015 at the SHEFFIELD FIRE DEPT., followed by the Pledge of Allegiance.

Ken stated our meetings are audio recorded and copies are available.

Alan made a motion to approve the minutes for the Regular and Special Meeting, Troy  $2^{nd}$ . All in favor.

- a) Claude (fire dept.) stated the squad is in service. The clock wasn't working they repaired it. Claude said the ambulance handles well. There was brief discussion about the old ambulance. Claude also asked about a background check on a junior.
- **b)** Natalie Shauberger (zoning) stated Halloween Bash is Oct 24 Natalie to send Dawn the flyer.
- c) Dale Hayes (resident) nothing
- d) Mark (road dept.) stated if they see any of the Monroe trustees, thank them for letting us use their One ton truck. Mark stated he has been able to put down cold patch because of the weather. Mark is getting information on a One Ton. He got a price on a demo unit for \$58,000. Dawn to advertise for bids to purchase a One ton truck. Deadline for bids will be Sept. 21<sup>st</sup>. Mark stated he will be working on ditching. Mark said someone is still spreading brine. Mark also asked can he take the EMS class coming up in Jan-Feb. Ken said it should not be a problem. Mark asked about mowing the back part of the cemetery Ken said it should be mowed at least once a year.
- e) Carl Baucum (resident) stated his daughter rides her horse on the road and the squad is running sirens next to the horse. He asked if they could silence them when passing the horse. Alan said that state law states if you have lights on that sirens should be on also. Ken said the chief would handle this. Carl also asked about rejoining the fire dept. Ken said that is also up to the chief.
- f) Dave Kray (fire chief) stated septic tank needs pumped. Dave will handle this. Dave stated they need vests Ken asked for the quote for fire gear to turn into Otarma for a grant. Dave said they have been getting used to the new squad. Dave complemented the new garage door. Ken to put in a cement apron for new garage door approx. 54 feet. There was discussion on the old squad, possibly advertising with the county auction site. Claude states they will remove some of the equipment. Dave said Mark is doing a good job. Dave also asked can he get quotes on painting the building.

Ken made a motion to return to regular session, Troy 2<sup>nd</sup> all in favor Resolution#64

Ken stated they discussed a volunteers background check - Dave to handle, we also discussed procedures with Mark with employees and issues. Also the position for fire chief was discussed will be decided in this meeting.


